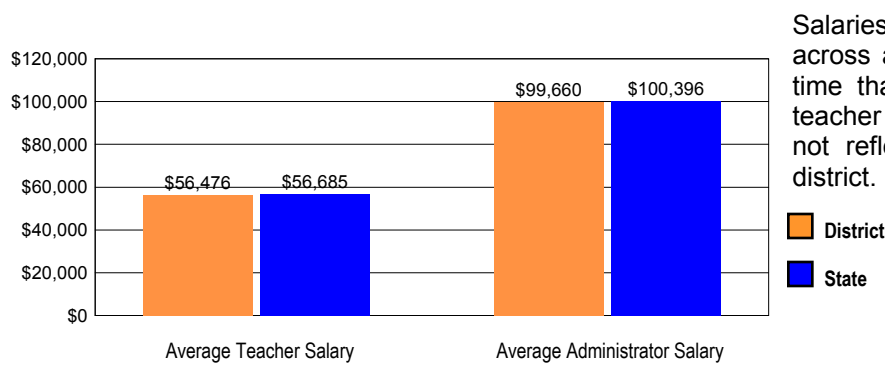

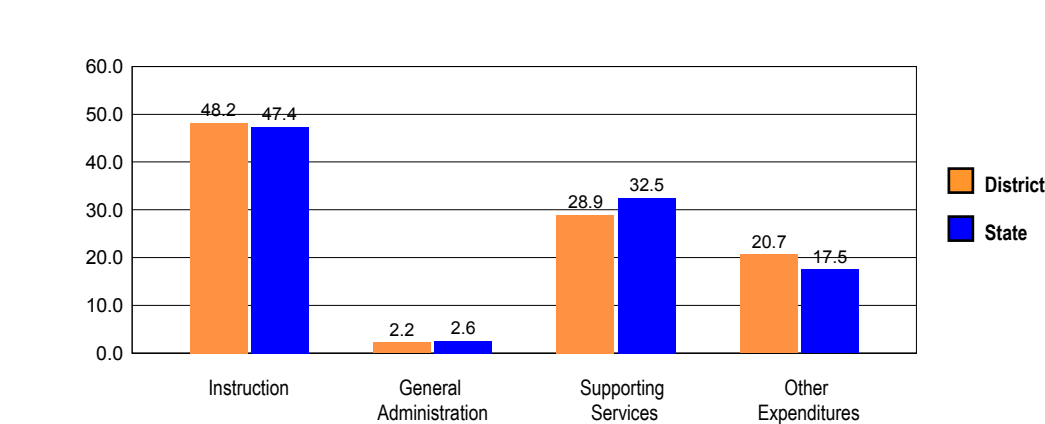

**EXPENDITURE BY FUNCTION 2004-05 (Percentages)**



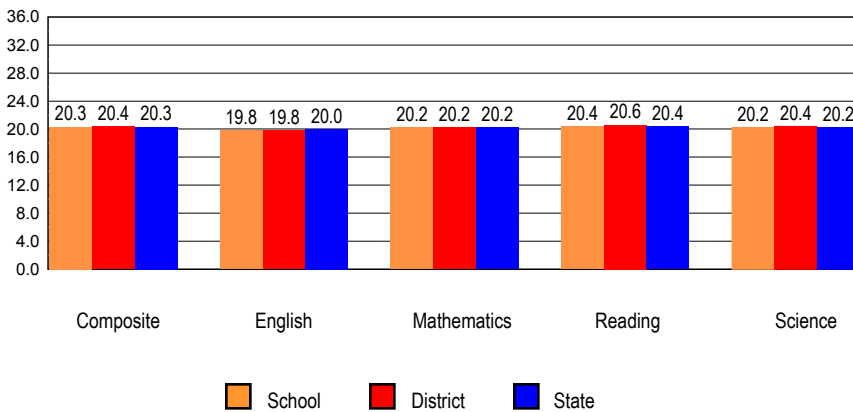

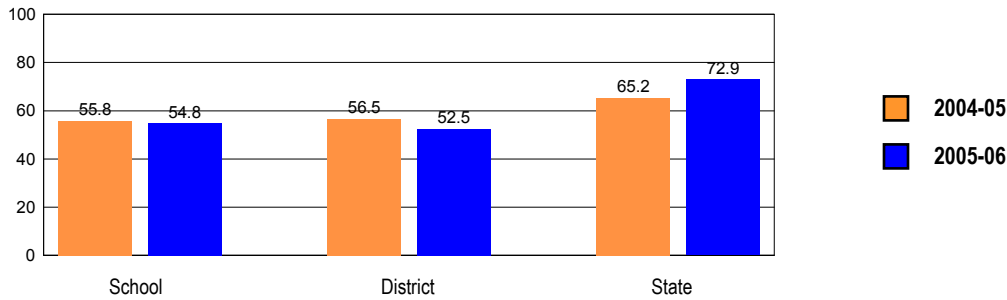

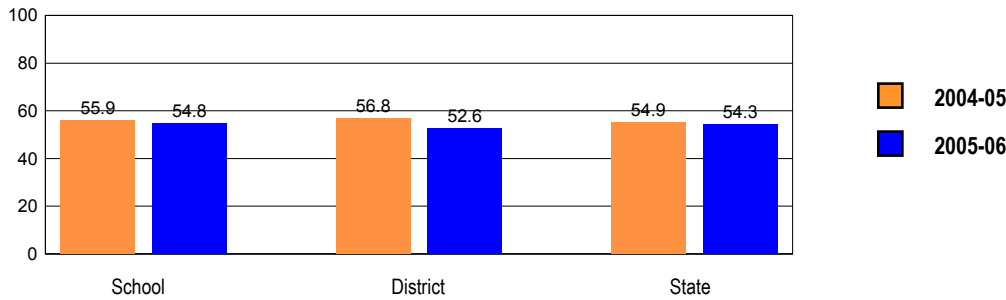

**OVERALL PERFORMANCE - ALL STATE TESTS**



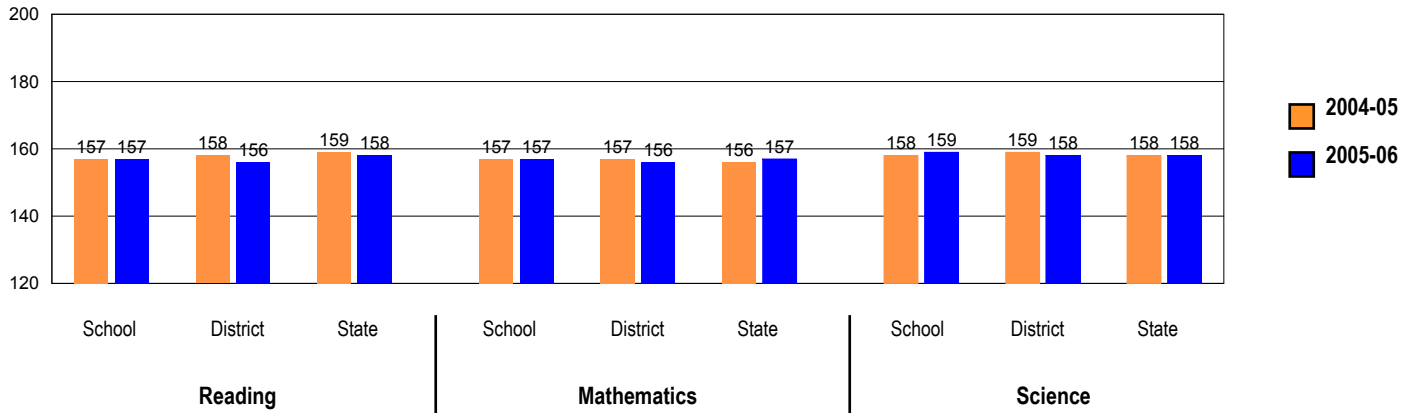
**OVERALL PRAIRIE STATE ACHIEVEMENT EXAMINATION (PSAE) PERFORMANCE**

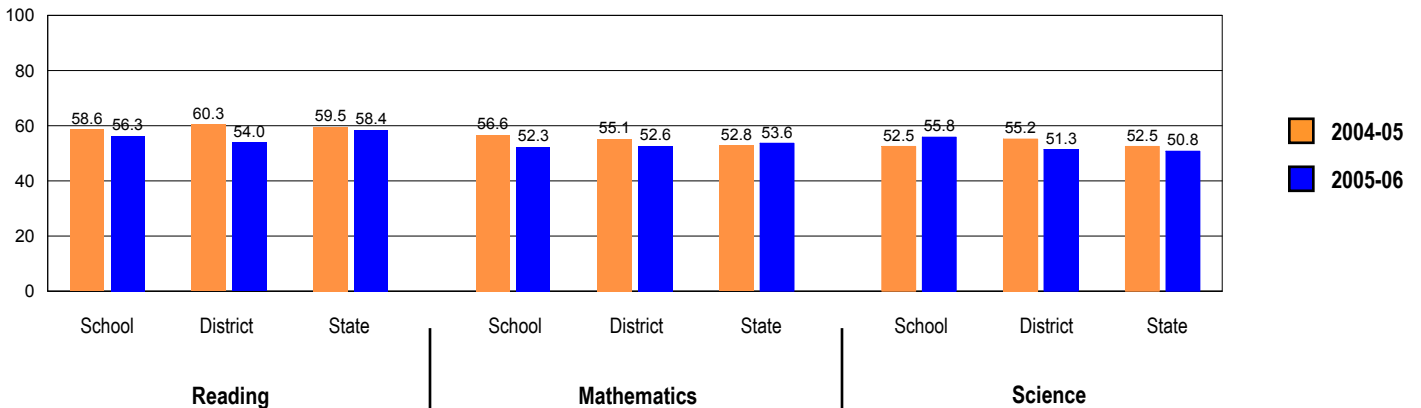

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Schools with grade 2 as the highest grade in the school use a state-adopted test in reading and mathematics to meet this requirement.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

### PRAIRIE STATE ACHIEVEMENT EXAMINATION (PSAE)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

The four conditions for making Adequate Yearly Progress (AYP) are:

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 47.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 47.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. \*\*\*
3. For schools not making AYP solely because the IEP group fails to have 47.5% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 89% attendance rate for non-high schools and at least 69% graduation rate for high schools.

\*\* Safe Harbor Targets of 47.5% or above are not printed.

\*\*\* Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

## **PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT**

McHenry East High School has achieved AYP for 2006, having met the requirements for the number of students tested, the percentage of students who meet or exceed in the areas of reading and math, the attendance rate, and the graduation rate. In particular, our graduation rate jumped from 84.7% in 2005 to 94.1% in 2006.

Unfortunately, the percentage of students who met or exceeded standards in reading and math went down from 2005. In both categories, East Campus has slipped slightly below the state average. In science, however, East's percentage of students who met or exceeded standards in science has gone up, and this year, has risen above the state average by 5 percentage points.

As part of our ongoing effort to improve achievement, faculty across the district is entering into the fourth year of a curriculum alignment project. Data from common assessments is being collected and analyzed by each department.

Credit recovery programs have been put in place. The Computer Assisted Learning Academy serves students who are not succeeding in the standard school setting. After-school tutoring programs have been set up to serve students who need help in core curricular areas.

Modifications in the sequence of course offerings in both the math and science departments are ready for implementation in the 2007-08 school year. Additional meeting time has been added to Advanced Placement Chemistry and Physics classes.

Reading initiatives are taking multiple forms. Two one-semester reading courses were added to the district curriculum this year. Reading I will be offered at East Campus in the fall of 2007. Core curricular areas are beginning to examine the role of vocabulary in student comprehension and overall achievement. Once vocabulary lists for each course have been generated they will be incorporated into instruction and evaluated using the common assessments.
